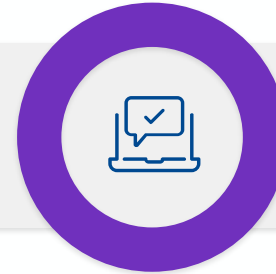

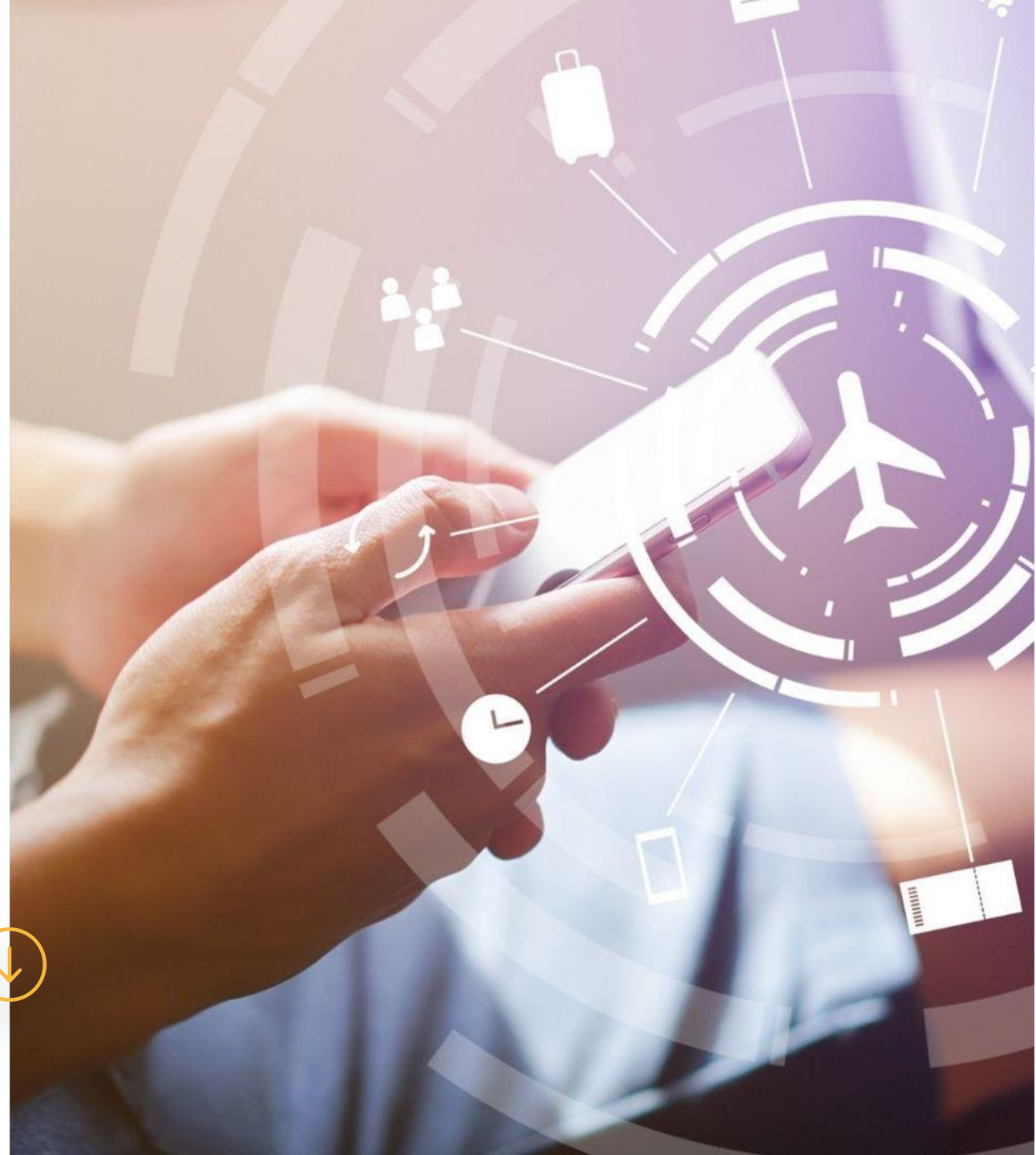
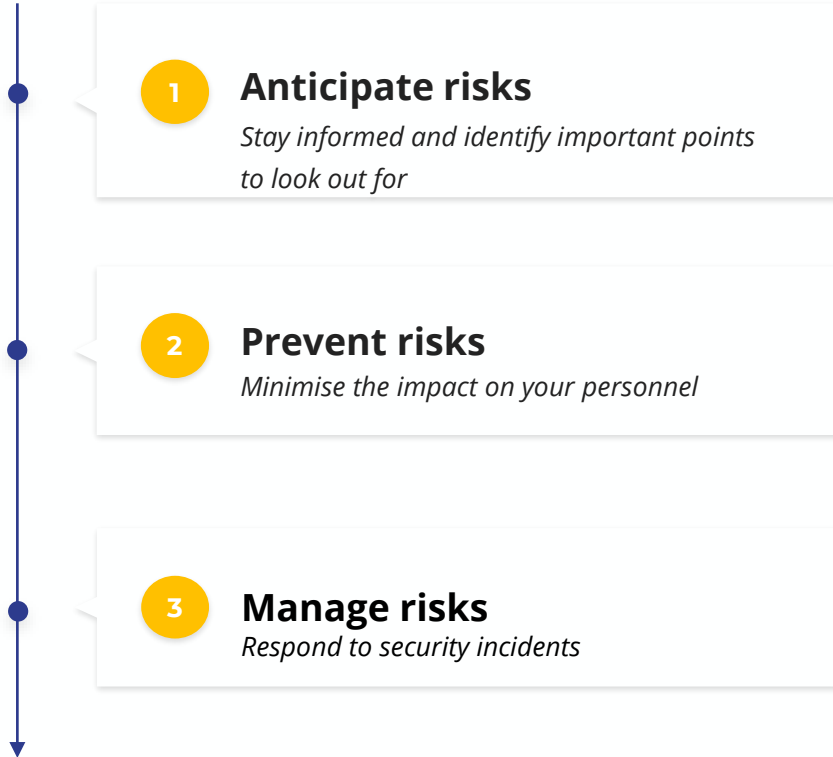

Anticipate risks



An analytical report prior to the event

- **A precise risk analysis** and assessment: probability, impact, vulnerable personnel
- **A map** of sensitive locations
- **A calendar** of notable events in France over the period
- An overview of the security measures in place for risk management
- Potential changes to current legislation



Enhanced informational intelligence before and during the period

- **Multi-faceted:** push notifications, targeted e-mail alerts, daily monitoring reports, weekly summaries
- **Multi-risk/theme** (terrorism, crime, socio-economics, disruption/travel, activism, environment, hooliganism, health and natural hazards, cyber/information, damage to the interests of operators, etc.)
- **Multi-site:** targeted monitoring of event sites, strategic transport infrastructure, accommodation areas, various POI, towns/regions and the national territory
- Statistical maps
- **Combing various sources:** official, local information, targeted monitoring of social media, feedback from the field, regional analyst closed sources and security actors.

Targeted alerts

Notification

Information alert only, aimed at anticipating events (demonstration, localised disruption etc.)

Warning

Moderate disruption, events or incidents with a limited impact causing limited damage

Critical

Severe disruption, events and incidents resulting in significant casualties and/or damage

Urgent

Breaking incidents involving disruption to normal life, which could result, or has resulted, in significant casualties and/or damage

Monitoring 24/7

Cross-checked information with geolocation

Open-source intelligence (OSINT) and field information

Geolocation of every event

Operation recommendations 24/7

Email notifications in real-time, in French and/or English

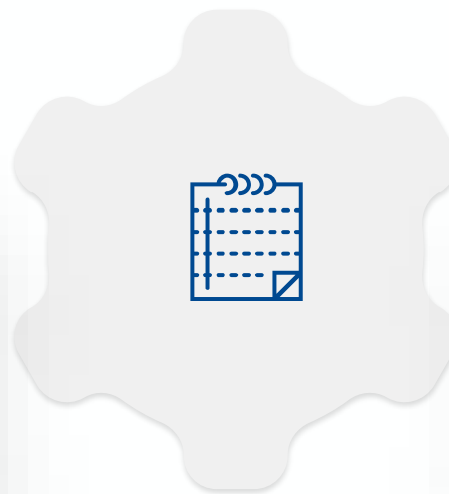

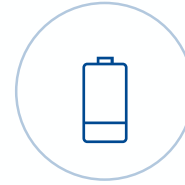

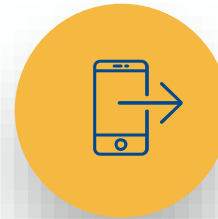

Handling emergencies

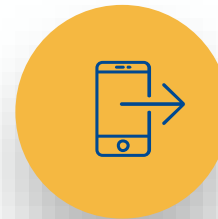
An operations centre works round-the-clock 24/7 to handle emergencies and process information on demand.
