Focal points in May

Burkina Faso

Large-scale jihadist attacks and secondary towns seized demonstrating a change in strategy; increase in fatal violence targeting civilians attributed to the army and vigilante militias.

United States Increase in socio-political tension in relation to the situation in the Gaza Strip, illustrated by targeted attacks, specifically on two staffers of the Israeli Embassy in Washington DC 21 May and a rally in support of the Israeli hostages detained by Hamas held in Boulder (Colorado) 1 June.

Libva

Renewed tension and armed clashes in Tripoli following the assassination of the commander of the Stability Support Apparatus (SSA), which was in control of one of the main areas of the capital, 12 May.

India/ Pakistan Ongoing tensions running high between the two countries with an escalation in strikes and exchange of fire in border areas at the start of the month. Relative calm following the announcement of an immediate bilateral ceasefire 10 May, but the security situation remains highly volatile.

Sudan

Further escalation and extension of the conflict with an increase in drone attacks carried out by the paramilitary targeting strategic infrastructure in cities in the north and east of the country positioned away from the frontline, such as Port Sudan, the de facto headquarters of the junta-led government.





Summaryof Alerts

+1,060 alerts +44 classified critical or urgent In May 2025, SSF issued a total of **1,060** safety–security alerts concerning all kinds of risks in order to inform its customers of the latest events likely to have an impact on their interests and the safety or security of their employees throughout the world. The alerts covered **143 countries**.

44 of the alerts were classified as either **critical or urgent**, which specifically activate our 24–hour Security Operations Centre (SOC).






10 countries to monitor



The countries that accounted for the highest number of alerts sent by SSF in May 2025 are the **United States, India, Israel** and the **Palestinian Territories, Pakistan, Germany, Mexico, Nigeria, Lebanon, Kenya** and **Peru**.

In total, these 10 countries generated **338 safety-security alerts**, representing **31%** of all the alerts sent over the last month.

Countries engaged in long–term warfare or with extremely high levels of insecurity in general (Afghanistan, Libya, Syria, Yemen, Somalia, Sudan and Ukraine) have been deliberately excluded from the list.

Germany

One dead and 7 people injured when a vehicle drove into a crowd of people in the central Olgaeck area of Stuttgart. At least 18 people injured, including 4 in a critical conditions, in a knife attack at Hamburg Central Station 23 May, before a female suspect was subsequently arrested. It is thought that she acted alone and was not politically motivated. One person injured in a revenge-related shooting in **Essen** (23 May). The Jenfeld neighbourhood of Hamburg was the scene of an incident (8 May) and a knife attack (25 May), leaving 2 people injured - The dissolution of the "Königreich Deutschland" ultranationalist network 13 May was presented by the authorities as a major step in combating extremism and conspiracy theories - Friedrich Merz elected to the Chancellerie (6 May), after losing the first vote, revealing considerable divisions across the German political arena – Two dead when a small aircraft crashed into a house in Korschenbroich 31 May – Warnings issued for **bad weather** in the centre and west of the country 3 May, and in Bavaria 28-29 May - State visit by the Israeli president to Berlin to celebrate 60 years of bilateral relations (12 May) - Multiple demonstrations, especially nationwide in commemoration of the 80th anniversary of the end of the Second World War (8-9 May) and against the AfD party (11 May), in Berlin against fascism (1 May), anti-Semitism (7 May), in Potsdam against budget cuts affecting schools (21 May).

United States

Increase in socio-political tension in relation to the situation in the Gaza Strip, giving rise to **targeted attacks**, specifically on two staffers of the Israeli Embassy in Washington DC 21 May and on a rally in support of the Israeli hostages detained by Hamas in Boulder (Colorado) 1 June – Significant series of **fatal shootings** across the country (at a shopping centre in Waterbury, Connecticut 27 May, in the Congress Heights area in Washington DC 26 May, in a restaurant in Glendale, Arizona 5 May and in a shopping centre in Spartanburg, South Carolina 2 May) – At least 27 dead in **violent tornadoes** in Kentucky,

Missouri and Virginia (16, 17 May), Alabama, Mississippi and Tennessee (21 May), Kansas (19 May) and in the Midwest (15 May).

Israel/Palestine

Several Israeli air raids on the Gaza Strip as part of the new land offensive by the army (5, 13, 14, 16, 18, 20, 22, 26, 28 May), leaving around 500 people dead. Israel also carried out air strikes on strategic infrastructure in the Sanaa region of Yemen (5, 6 May) and on a Hezbollah commander in southern Lebanon (15 May). The Houthis fired several missiles at Israel in support of the Palestinian people (2, 3, 13, 14, 15, 22, 25, 27, 29 May), notably hitting Ben Gurion Airport in Tel Aviv (4, 9, 18 May). Most of the strikes were intercepted or only inflicted minor injuries - West Bank: diplomatic tensions running high after the Israeli army opened fire on a diplomatic delegation of several countries in Jenin (22 May). Ongoing daily violence between Palestinians and Israeli soldiers/settlers (5 Palestinians killed by the IDF in Tamun and 2 Israelis injured near the Bruchin settlement 15 May) – **Jerusalem**: policeman injured in a knife attack at Temple Mount 16 May. "March of Flags" took place under tension 26 May and inter-religious march for human rights and peace held 28 May. More than 13,000 hectares of land destroyed in intense forest fires in the area around Jerusalem - Tel Aviv: clashes on the fringes of a demonstration in demand of the release of the hostages (29 May), demonstrations against the prime minister and in support of the hostages (16 May) - Haifa District: criminal rocket attack in Kiryat Ata (4 May) - South: rockets fired from Gaza near border communities (13, 18, 31 May).

India/Pakistan

Tensions continue to run high between India and Pakistan, as the security situation remains extremely volatile. Immediate bilateral ceasefire announced (10 May), air traffic progressively resumed (11-12 May) following several suspensions and temporary closures of airspace. Ban on Indian carriers flying over Pakistan airspace extended (23 May), reciprocal measures by India (23 May) until 24 June.

- Border areas: Indian military strikes on so-called terrorist infrastructure (6, 7, 8, 9 May) and air bases in Pakistan (10 May). Pakistan retaliated by bombing Indian territory (8, 9 May). Escalation in exchange of fire at the Line of Control (7, 8 May) leaving at least 37 Pakistan and 16 Indian civilians dead.
- (India) Jammu and Kashmir: shooting between suspected members of a terrorist group and the Indian army, at least 3 insurgents killed (13 May) - Hyderabad: 17 dead in a fire near Gulzar Houz (18 May) - Assam State: at least 5 dead in flooding and landslides (31 May) – Punjab State: farmers block railway lines (6, 7 May), strike led by public transport workers from 20 to 22 May - Goa State: 6 dead in a stampede at the Lairai Devi Temple in Shrigao (3 May) – Chhattisgarh State: 25 Maoist insurgents killed in a skirmish with the security forces (21 May) – West Bengal State: clashe reported on the fringes of a demonstration staged by teachers in Calcutta following layoffs (15 May) - Raiasthan State: anti-government rally by the Indian National Congress in Churu (22 May) - Nationwide: BJP demonstrations celebrating the Indian bombing in Pakistan (13 to 23 May). Civil defence mock drills in several states (7, 31 May).

(Pakistan) Border with Afghanistan: armed clashes between the Taliban and Pakistani border guards in Helmand Province (Afghanistan) 29 May - Balochistan: in Quetta, 2 dead in explosions in Hana Orak (31 May) and 6 people injured in a rally held by the Pakistan People's Party (PPP) 14 May. 4 dead in a suicide bombing in Khuzdar (21 May). Balochistan Liberation Army (BLA) claims responsibility for kidnapping 5 police officers in Kalat (2 May), a bomb explosion near Mach, in which 6 paramilitaries were killed (6 May), and a coordinated attack in Surab (30 May) - Sindh Province: one civilian killed in clashes between the police and nationalist demonstrators in Moro 20 May - Gujarat: a Pakistani national shot dead by the Indian army, Banaskantha (23 May) - Khyber-Pakhtunkhwa: 9 militants affiliated with Tehreek-i-Taliban (TTP) eliminated by the Pakistani army (25 May) – At least 32 dead and 150 people injured in violent storms in the centre and north of the country since 24 May.

Kenya

Nairobi: an MP shot dead by two motorcycle-riding individuals on Ngong Road 30 April. Tension during the launch of the new party of former Vice President Rigathi Gachagua after a group of unidentified individuals launched an assault on the premises (15 May). Demonstrations staged by employees of Universal Health Coverage (UHC) (20, 21 May) and students from Kenya Utalii College after the body of a fellow student was discovered (30 May). Mandera County: at least 5 dead in a Shebab attack on a vehicle carrying guarry workers in the village of Bur Abor 29 April - Nyeri County: clashes between rival political supporters in Karatina (20 May) - Elgeyo-Marakwet County: curfew declared in Kerio Valley from 23 May following the murder of a Catholic priest - Makueni County: Nairobi-Mombasa highway blocked in Kiboko following the killing of a suspected thief by a local businessman (14 May). Embu County: demonstration and roadblock underway in Embu in reaction to growing insecurity (28 May) – Nationwide: demonstrations following the arrest of the governor of Trans-Nzoia in Kitale (19 May) and national strike and demonstrations staged by student teachers (19 May) in condemnation of the government's refusal to give them permanent contracts.

Lebanon

South: at least 11 dead in repeated Israeli strikes targeting suspected Hezbollah members and infrastructure, despite ceasefire (1, 5, 8, 15, 17, 18, 20, 21, 22, 27, 30, 31 May). UNIFIL patrol attacked in Yater by men in plain clothes (28 May) – Tripoli: tension on the fringes of the municipal elections following a rally in condemnation of alleged fraud – South Lebanon and Nabatieh governorates: municipal elections 24 May – Beirut, Baalbek-Hermel and Bekaa governorates: municipal elections 18 May – North Lebanon and Akkar governorates: municipal elections 11 May – Mount Lebanon Governorate: municipal elections 4 May.

Mexico

Wave of intimidation and attacks recorded nationwide ahead of the judicial and municipal elections 1 June - Sinaloa: at least 39 dead and 97 people missing since September in relation to a conflict between two factions of the Sinaloa Cartel -Guanajuato: 7 dead in a shooting during a religious festival in San Bartolo de Berrios 19 May. Suspected murder of 17 people in Irapuato 27 May - Guerrero: 6 dead in an armed cash near Acapulco 19 May – **Veracruz**: 4 dead in a shooting, including a mayoral candidate in Texistepec 11 May - Tamaulipas: 5 musicians killed by suspected cartel members in Reynosa 29 May – **State of Mexico**: 2 of the Mexico City mayor's top aides killed in Moderna 20 May. 7 people injured when a concert stage collapsed in Gustavo A. Madero 8 May. 2 dead in traffic accidents on the Mexico-Queretaro road 26 May. Demonstrations in Mexico City against insecurity 8 May, in the education industry 21 May, resulting in a blockade at Benito Juarez International Airport (MEX) 23-24 May - Michoacan and Jalisco: 8 soldiers killed when a landmine exploded in El Santuario 27 May – **Puebla**: 21 dead in a road accident south of Puebla 14 May - Chihuahua: military plane crash at Chihuahua Airport, resulting in the temporary suspension temporaire of flights 19 May - Tropical Storm Alvin on the west coast from 31 May.

Nigeria

Niger State: at least 150 people lost their lives in flooding in the Mokwa LGA since 29 May – Benue: 44 dead in various attacks in the area of Gwer West (23-26 May). 23 dead in attacks by armed herdsmen in the areas of Logo, Kwande, Ukum and Guma (9-10 May). 15 traders killed in an ambush in the Agatu area (18 May) – Borno: attacks by the Islamic State West Africa Province (ISWAP) and Boko Haram leave 22 dead, including 17 civilians, in Wulgo and Baga (15-16 May), 9 civilians dead in Gajibo (23-24 May), and 6 soldiers killed in assaults on military bases in Marte (12-13 May) and New Marte (27 May). 8 members of a vigilante militia killed when a landmine exploded on the Marte-Dikwa road (27 May).

60 Boko Haram fighters reportedly neutralised by the Nigerian army near Gwoza 31 May - Imo: 30 dead in an attack by armed men on the Owerri-Okiqwe road 8 May - Katsina: 20 people killed in an attack by armed men in Gobirawa 17 May -Bauchi: 19 dead in an ambush by suspected armed bandits in Gwana District 4 May - Kebbi 15 farmers shot dead by armed individuals in Waje 17 May – **Sokoto**: attacks by armed groups in Isa District leave 12 dead 11-12 May, over 5,000 residents flee - Plateau: 6 people killed by armed men in Marit 6 May -Taraba: 30 people killed by attackers in Munga and Magami 24 May – **Yobe**: 11 soldiers killed by the ISWAP at a military base in Buni Gari 3 May - Zamfara: 20 people killed by armed bandits and in a military strike in the Maru region 31 May -Southeast: shutdown imposed by the Indigenous People of Biafra (IPOB) group, on the occasion of Biafra Remembrance Day (29-30 May) – **Abuja**: explosion outside a military barracks in the city centre 26 May.

Peru

La Libertad Region: 13 bodies of workers found in a mine 4 May after they were kidnapped in Pataz, illustrating violence related to illegal gold mining. Security increased to combat organised crime in the area, including a curfew in the Pataz district 5 May, as well as a 30-day suspension of all mining activities. State of emergency extended in the provinces of Viru and Trujillo until 7 July, as well as in Pataz Province until 7 June (curfew in the districts of Pataz, Parcoy and Tayabamba) -Loreto Region: a journalist at La Karibeña radio station assassinated in Iquitos 8 May, sparking protests against growing organised crime - Lima District and Callao Province: 30-day extension of the **state of emergency** 17 May in reaction to a wave of violence linked to racketeering networks and targeted killings - Lima: one dead in a shooting and a car chase on the Via Expresa 21 May - Amazonia: 2 dead in a collision involving a military vessel and an oil platform on the Napo River (3 May) - Nationwide: general strike and demonstrations against insecurity 14 May.

Singapore: security stepped up on the occasion of the Shangri-La Dialogue, the Asia Security Summit .

1 to 3 June

Israel: Festival of Shavuot across the country – Jewish celebrations should be expected.

1 to 30 June

World: Pride Month – Demonstrations and disruption should be expected.

1 June

Croatia: second round of the municipal elections – Security reinforcements and disruption should be expected.

Italy: transport strike in Genoa – Demonstrations and disruption should be expected.

Kenya: Madaraka Day celebrating Kenya's internal self-rule gained from the United Kingdom (1963) - Celebrations likely.

Mexico: judicial elections – Security reinforcements should be expected, rallies possible.

Poland: second round of the presidential election – Security reinforcements and disruption should be expected.

Thailand: Bangkok Gay Pride Parade – Security reinforcements and disruption should be expected.

2 to 4 June

Iran: speech by Iran's supreme leader for the commemoration of the death of Khomeini.

2 to 7 June

Germany: environmental demonstrations scheduled in Berlin – Security reinforcements and localised disruption should be expected.

2 June to 31 July

United Kingdom: trial of a British man in London, charged with planning arson attacks on Ukrainian companies for Russia.

2 June

Benin: verdict in the Cotonou trial of cyber-activist, Steve Amoussou, critical of the government.

Bulgaria: healthcare workers set to stage demonstrations nationwide – Disruption should be expected, incidents possible.

Ghana: national strike in the medical sector – Demonstrations and disruption should be expected.

Italy: Republic Day (1946).

Lebanon: general strike in the civil service – Demonstrations and disruption should be expected.

Mali: court ruling on the dispute between the Malian junta and Canadian mining firm, Barrick Gold.

Russia: Foreign Ministry Sergey Lavrov to meet with UN Humanitarian Chief Tom Fletcher in Moscow.

Tanzania: trial of opponent Tundu Lissu – Security reinforcements and risk of demonstrations.

3 and 4 June

Greece: unionised maritime workers set to go on strike – Likely disruption affecting maritime transport.

South Korea: snap presidential election – Security reinforcements and disruption should be expected.

Indonesia: trade union demonstration in Jakarta – Disruption should be expected. **Iran**: anniversary of the death of Ayatollah Khomeini (1989).

Italy: Prime Minister Giorgia Meloni to meet with French President Emmanuel Macron.

Montenegro: Independence Day (2006).

Sudan: anniversary of the sit-in staged during the people's revolution (2019) – Demonstrations amid current conflict should not be ruled out.

Uganda: Martyrs' Day celebrations marking the massacre of 45 Christian converts by King Mwanga between November 1885 and January 1887 – Security reinforcements and disruption likely, notably in Kampala.

4 June

Bolivia: roadblocks to be set up nationwide by supporters of the former president – Disruption should be expected across cities.

Brazil: opening of the 11th BRICS Parliamentary Forum in Brasilia.

Chine, Hong Kong, Taiwan: anniversary of the crackdown on the Tiananmen Square protests (1989) – Rallies likely, notably in Macau, Taipei & Hong Kong – Clashes possible.

Sweden: jihadist, Osama Krayem, trial in Stockholm, charged with the muder of a Jordanian pilot in Syria.

United Kingdom: demonstrations in London in commemoration of the crackdown on Tiananmen Square, and in support of Palestine – Security reinforcements and localised disruption should be expected.

4 and 5 June

Chile: national strike action by teachers – Rallies should be expected.

Italy: strike action in the freight train industry – Disruption is possible across the passenger network.

4 to 9 June

Saudi Arabia: disruption should be expected, especially at airports, on the occasion of the Hajj pilgrimage.

4, 5 and 11 June

France: another strike notice issued by the SNCF – Disruption should be expected across the whole of the rail network.

5 June

Belgium: meeting of NATO defence ministers in Brussels – Security reinforcements and disruption should be expected.

Burundi: legislative and town council elections – Security reinforcements and disruption should be expected.

Cyprus: civil society rally in Nicosia – Security reinforcements and disruption should be expected.

France: strike action led by the CGT-Cheminots union at the SNCF – Demonstrations should be expected.

France: forum between France and the US on anti-Semitism in Paris – Rallies should be expected.

India: anniversary of the army operation at the Golden Temple in Amritsar (1984) – Sikh rallies to be expected across the whole of Punjab State, violence possible between Sikh communities and radical Hindu movements.

Israel: Jerusalem Gay Pride – Increased security should be expected, tension possible.

Muslim World: Naksa Day, marking the anniversary of the start of the Six Day War in 1967 between Israel and Arab countries – Demonstrations likely.

World: World Environment Day – Rallies to be expected.

Germany: environmental demonstration in Nuremberg – Localised disruption should be expected.

Bolivia: electoral authorities set to publish the list of candidates eligible to stand in the presidential election – Supporter rallies should be expected.

Brazil: demonstration at Rio de Janeiro Santos Dumont Airport (SDU) – Localised disruption should be expected.

France: 81st anniversary of the Allied Normandy landings (1944) – Commemorations should be expected.

Greece: strike in the civil service – Rallies should be expected.

India: strike action led by a sikh group in Amritsar in commemoration of the anniversary of Operation Bluestar – Sikh rallies should be expected, violence possible.

Lebanon: anniversary of Israel's launch of Operation Peace for Galilee (1982). **New Zealand**: demonstration by a Sikh movement in Wellington – Increased security and localised disruption should be expected.

Poland: demonstration against immigration in Lublin – Security reinforcements and localised disruption should be expected.

South Korea: Memorial Day – Commemorations should be expected.

United Kingdom: 81st anniversary of D-Day – Commemorations should be expected.

United States: demonstration against budget cuts by the Trump administration in Washington DC – Increased security and localised disruption should be expected.

World: Eid al-Adha celebrated by Muslims – Festivities should be expected.

7 June

Brazil: environmental demonstration in Sao Paulo – Localised disruption should be expected.

Equatorial Guinea: 26th Ordinary Session of the Conference of the. Heads of State and Government of the Economic Community of Central African States (ECCAS) – Security reinforcements should be expected.

Iran: anniversary of the terrorist attacks on parliament and the mausoleum of imam Khomeini in Tehran, claimed by the Islamic State group (17 dead, 2017). **Iraq/Jordan**: anniversary of the death of Jordan man, Abu Musab al-Zarqawi, formerly the leader of Al-Qaeda in Iraq (2006).

Lithuania: anti-LGBTQIA+ demonstration in Vilnius – Security reinforcements should be expected.

Romania: Bucharest Pride – Security reinforcements should be expected.

Spain: demonstration for peace and against Spanish rearmament in Madrid – Security reinforcements and localised disruption should be expected.

Switzerland: demonstration by civil rights activists in Lausanne – Security reinforcements and localised disruption should be expected.

United Kingdom: anti-austerity march and rally in London – Security reinforcements and localised disruption should be expected.

United States: rival demonstrations for and against abortion in Philadelphia – Security reinforcements should be expected, incidents possible.

8 June to 9 June

Italy: citizenship referendum and second round of the local elections – Security reinforcements and disruption should be expected.

Serbia: local elections in Kosjeric, the first ballot since the protest movement in the country – Risk of incidents amid election-related tension.

Spain: demonstration led by the People's Party in protest against the government of Pedro Sánchez in Madrid – Security reinforcements and localised disruption should be expected.

World: World Oceans Day – Rallies to be expected in several countries.

9 and 11 June

Bosnia-Herzegovina: strike action and rally staged by teachers and doctors in the canton of Una-Sana – Security reinforcements and localised disruption should be expected.

9 June

Canada: strike action led by maintenance workers at the STM transport company in Montreal – Potential transport disruption, particularly affecting the metro.

France: "Victory Day" celebration by the Patriots of Europe group with Le Pen, Bardella, Orban and Salvini in attendance – Security reinforcements and rallies among supporters should be expected.

Jordan: anniversary of the accession to the throne of King Abdullah II (1999) – Security reinforcements to be expected.

Myanmar: anniversary of the end of the ceasefire between the Kachin Independence Army (KIA) and the Myanmar military (2011) - Renewed attacks possible.

World: anniversary of the offensive by the Islamic State group (IS) in Iraq (2014).

10 and 11 June

Argentine: pilot strike at the AR carrier in two airports – Disruption should be expected, rallies possible.

10 June

Indonesia: national demonstration led by trade unions – Security reinforcements and localised disruption should be expected.

Iraq: Mosul Airport reopening ceremony – Security reinforcements should be expected.

Kosovo: anniversary of the withdrawal of the Serb forces from Kosovo (1999) – Demonstrations possible amid a surge in tension between Serbs and Kosovars in the north of the country.

Kyrgyzstan: anniversary of inter-ethnic violence of 2010 between Kyrgyz and Uzbek nationals in Osh and Jalal-Abad – Demonstrations possible.

Mexico: anniversary of the "El Halconazo" massacre (1971) – Rallies should not be ruled out.

Singapore: preliminary hearing in the trial of Malaysian hotel tycoon, Ong Beng Seng, linked to the imprisoned former Singaporean transport minister – Security reinforcements should be expected.

11 to 15 June

France: 24 Hours of Le Mans, endurance car race – Security reinforcements and localised disruption should be expected.

11 June

France: trial of White supremacist, Alexis Issaurat, for making death threats against the former public prosecutor of Nice – Security reinforcements should be expected.

Philippines: Senate set to examine a resolution for the impeachment of the vice president – Increased security and political rallies should be expected, along with a risk of incidents.

Poland: vote of confidence against the government – Political rallies should be expected, incidents possible amid post-election tensio.

Taiwan: press conference on simulation by Taiwanese troops during the island's annual war games.

12 au 15 June

United Kingdom: Men's London Fashion Week – Localised disruption should be expected.

12 June

Tunisia: another hearing in the trial of female opponent, Abir Moussi, charged in accordance with the decree on fake news – Rallies and increased security should be expected.

World: World Day Against Child Labour.

France: Socialist Party (PS) congress – Rallies and increased security should be expected.

France: official opening of the new high-speed Trenitalia train line between Paris and Marseille.

13 June

Iran: anniversary of the Iranian Green Movement, sprung from the protests against the re-election of President Mahmoud Ahmadinejad (2009).

Italy: national strike in the aviation industry – Disruption should be expected.

Philippines: traffic disruption expected in Metro Manila due to the start of long-term works on Epifanio de los Santos Avenue (EDSA).

United Kingdom: court appearance of individuals linked to the Conservative party accused of fraudulent betting on the date of the elections – Rallies and increased security should be expected.

14 June

Europe: 40th anniversary of the Schengen Agreement, allowing the gradual removal of controls at borders between member countries.

Greece: 40th anniversary of the hijacking of flight TWA 847 Athens-Rome by members of Hezbollah – Commemorations should be expected.

United Kingdom: Trooping the Colour military parade to celebrate the King's birthday in London – Increased security should be expected.

United States: 250th anniversary of the founding of the US Army – Celebrations should be expected.

United States: renewed national demonstrations led by the 50501 movement – Security reinforcements should be expected, high risk of unrest.

Thailand: anniversary of the founding of the Sultanate of Patani (1457) – Risk of attacks in the south.

Türkiye: 55th anniversary of the workers' riots led by the far-left in Istanbul (1970) – Risk of demonstrations.

16 June to 11 July

Switzerland: 59th 59th session of the UN Human Rights Council in Geneva – Increased security should be expected.

Bangladesh: anniversary of the attack on the Bangladesh Awami League (AL), in which 20 people were killed (2001) – Demonstrations possible by the AL.

South Africa: National Youth Day commemorating the Soweto Uprising (1976) – Demonstrations and security reinforcements likely, notably in Johannesburg.

South Africa: EFF rally in Umlazi (KwaZulu-Natal) – Increased security and risk of incidents.

Türkiye: trial of Istanbul Mayor Ekrem Imamoglu on charges of threatening the public prosecutor of Istanbul – Risk of demonstrations and clashes. Security reinforcements should be expected.

United States: High-level International Conference for the Peaceful Settlement of the Question of Palestine and the Implementation of the Two-State Solution – Security reinforcements and disruption should be expected.

France: ruling on the sentence of former Prime Minister François Fillon in relation to the case of the fictitious employment of his wife, Penelope.

Kenya: sentencing hearing for two men found guilty of the terrorist attack on the Dusit D2 Hotel – Security reinforcements should be expected.

Myanmar: 80th birthday of former leader, Aung San Suu Kyi – Rallies among her supporters should be expected, risk of incidents.

United Kingdom: sentencing of Chinese PhD student, Zhenhao Zou, found guilty of drugging and raping 10 women – Security reinforcements should be expected, rallies possible.

Ivory Coast: RHDP ruling party congress – Security stepped up, supporter rallies and a risk of incidents.

World: World Refugee Day – Demonstrations likely.

France: demonstration in support of human rights in Türkiye outside the European Council in Strasbourg – Increased security and localised disruption should be expected.

Kenya: first anniversary of the storming of parliament by demonstrators – Security reinforcements should be expected.

26 to 27 June

South Africa: sentencing of seven Chinese nationals accused of human trafficking – Increased security should be expected.

26 June

United States: special session of the UN General Assembly to mark the 80th anniversary of the UN – Commemorations should be expected.

India: national strike in the electricity industry – Rallies and disruption should be expected.

Israel: concert to pay tribute to the victims of the Nova music festival in Tel Aviv – Security reinforcements should be expected, risk of demonstrations.

27 June

Nigeria: verdict in the case against suspended Senator Natasha Akpoti-Uduaghan – Security reinforcements should be expected.

28 June

Hungary: Budapest Pride March despite government measures to ban the event – Security reinforcements should be expected.

Ireland: anniversary of the start of the Irish Civil War.

29 June

Algeria: anniversary of the assassination of Algerian head of state, Mohamed Boudiaf – Commemorations likely.

30 June

France: meeting of the Madagascar-France Commission on the Scattered Islands – Security reinforcements should be expected.
