## Focal points in June

United States

**Clashes** between demonstrators opposed to federal immigration policies and the police in **Los Angeles**, after the Immigration and Customs Enforcement (ICE) agency carried out a series of arrests in several neighbourhoods of the city, targeting undocumented immigrants (6-14 June). Curfew declared 10 June and National Guard, along with the Marines, deployed by President Trump. In response, clashes and incidents were reported on the fringes of national "No Kings" anti-Trump mass demonstrations.

- India At least 279 people killed, including 38 on the ground, when an Air India plane (flight Al 171), which had just taken off from Ahmedabad International Airport, bound for London, crashed into the BJ Medical College complex 12 June.
- Israel/Iran Israel launched its Operation Rising Lion military offensive on Iran 13 June, resulting in the bombing of over 1,100 military sites, 8 nuclear sites and 300 missiles launch pads, with an estimated death toll of over 900, including a majority of civilians and high-ranking representatives of the Islamic Republic; ceasefire imposed by the US 24 June following brief involvement in the conflict in the form of air strikes on the nuclear sites of Fordo, Natanz and Ispahan 22 June. The Iranian response consisted mainly of daily missile attacks on Israel, particularly Tel Aviv, Haifa and Be'er Sheva (28 dead) and an attack on the US military base at al-Udeid (Qatar).

Thailand Renewed tension with Cambodia following an armed skirmish at the border 28 May, in which a Cambodian soldier was killed. Several border crossings closed and other travel restrictions imposed, including on the movement of goods. Prime Minister Paetongtarn Shinawatra suspended by the Constitutional Court 1 July in the wake of a leaked controversial telephone call with former Cambodian Prime Minister Hun Sen.

## **Countries to monitor in July**


2, 4, 7, 16, 18, 21 and 23 July: trade union strike action at Finland Helsinki Airport – Major disruption should be expected. 7 July: Israeli Prime Minister Benjamin Netanyahu to pay a visit United States to the White House in Washington – Security reinforcements should be expected, risk of demonstrations. 7 July: Saba Saba Day commemorating the death of Kenya demonstrators in 1990 - Rallies should not be ruled out given the tense socio-political climate. **17 July**: municipal elections (initially scheduled 10 July) – Togo Security reinforcements and disruption should be expected; rallies should not be ruled out. Venezuela 27 & 28 July: renewed demonstrations and tension should not be ruled out on the occasion of the municipal elections (27 July) and the first anniversary of the re-election of President Nicolas Maduro (28 July), which saw a violent crackdown a post-election protest movement.


## \_ Summary of Alerts

+1,114 alerts +177 classified critical or urgent

In June 2025, SSF issued a total of 1,114 safety-security alerts concerning all kinds of risks in order to inform its customers of the latest events likely to have an impact on their interests and the safety or security of their employees throughout the world. The alerts covered 130 countries.

177 of the alerts were classified as either critical or urgent, which specifically activate our 24-hour Security Operations Centre (SOC).






# 10 countries to monitor



The countries that accounted for the highest number of alerts sent by SSF in June 2025 are **Israel** and the **Palestinian Territories**, the **United States**, **India**, **Iran**, the **United Kingdom**, **Türkiye**, **Colombia**, **Nigeria**, **Kenya** and **Thailand**.

In total, these 10 countries generated **372 safety–security alerts**, representing **33%** of all the alerts sent over the last month.

Countries engaged in long–term warfare or with extremely high levels of insecurity in general (Afghanistan, Libya, Syria, Yemen, Somalia, Sudan and Ukraine) have been deliberately excluded from the list.

#### Colombia

Bogota: presidential candidate conservative Senator Miguel Uribe seriously injured in a shooting, which the government called an attack (7 June) - Valle del Cauca and Cauca departments: 8 people killed and 30 injured in 7 coordinated attacks, including 4 bombings, targeting police stations and municipal buildings in Cali and several neighbouring areas; suspicion falls on FARC dissidents (10 June). Several people injured in a grenade attack near a hotel in Piendamo (1 June) and an explosive attack in Buenaventura, 1 person injured (12 June). At least 57 soldiers held hostage by locals in military operations (21 June) - Antioquia Department: at least 8 dead following a landslide in Bello (24 June). March "for peace" in Medellín led by President Gustavo Petro (21 June) Cundinamarca Department: earthquake measuring 6.3 strikes not far from Paratebueno, effects strongly felt in Bogota; at least 4 people injured and minor material damage (8 June) - La Guajira Department: at least 2 dead when a car bomb explodes at the Alto Pino pay toll (20 June) - Guaviare Department: armed strike led by FARC dissidents from 16 to 21 June - Nationwide: silent marches to pay tribute to Miguel Uribe (15 June) and demonstrations in support of social reforms (11 June).

#### **United States**

**California State**: clashes between demonstrators opposed to federal immigrations policies and the police in Los Angeles after the Immigration and Customs Enforcement (ICE) agency carried out a series of arrests in several neighbourhoods of the city, targeting undocumented immigrants (6-14 June). Curfew declared (10 June) and National Guard, along with the Marines, deployed by President Trump (8, 9 June) - Idaho State: 2 fire-fighters killed by a sniper in an ambush in Coeur d'Alene – Minnesota State: at least 2 dead in a shooting targeting lawmakers in Brooklyn Park (14 June). 4 people injured in a shooting near Boom Island Park in Minneapolis (1 June) – Texas State: 10 dead in flooding in San Antonio (12, 13 June). National Guard deployed by the state governor in relation to the protest movement against ICE and the Trump administration (11 June).

- West Virginia State: at least 6 dead and 2 people missing in widespread flooding inondations (14 June), state of emergency declared in Ohio County (15 June) – Washington DC: military parade for the 250th anniversary of the US Army (14 June). At least 3 people injured in a shooting and knife attack near Dupont Circle (8 June) – Nationwide: clashes and incidents reported on the fringes of the "No Kings" mass protest movement against Trump.

#### India

Ahmedabad: at least 279 people killed, including 38 on the ground, when an Air India plane (flight AI 171), which had just taken off from Ahmedabad International Airport, bound for London, crashed into the BJ Medical College complex. Just one passenger survived (12 June) - Bangalore: at least 10 dead in a deadly stampede at the M. Chinnaswamy Stadium (4 June) -States in the northeast: at least 32 dead in heavy monsoon rains across several states (1 June) - Himachal Pradesh State: at least 31 dead and 4 people missing in heavy rain and flash-flooding (20 to 29 June) - Telangana State: at least 10 dead in an explosion at a chemical plant in Sangareddy (30 June) - Sikkim State: at least 3 soldiers killed and 6 missing in a landslide caused by torrential rain - Odisha State: at least 3 dead in a stampede during Rath Yatra in Puri (29 June) -Maharashtra State: at least 2 dead and 30 people injured when a bridge collapsed in Pune District (15 June) - Manipur State: curfew declared in several districts following inter-ethnic violence (7 June) - New Delhi: bad weather causes air traffic disruption at Indira Gandhi INternational Airport (1,17 June).

#### Iran

Launch of Israel's **Operation Rising Lion military offensive** on Iran 13 June, resulting in the bombing of over 1,100 military sites, 8 nuclear sites and 300 missiles launch pads, with an estimated **death toll** of over **900**, including a majority of civilians and high-ranking representatives of the Islamic Republic; **ceasefire imposed by the US 24 June** following a brief involvement in the conflict in the form of air strikes on the nuclear sites of Fordo, Natanz and Ispahan 22 June. **Credible risk of renewed Israeli operations in the medium-term** unless the ceasefire is framed by diplomatic regulations, notably concerning **remaining potential nuclear capabilities**. Although Donald Trump and certain Israeli officials claimed that the programme has been "totally destroyed", reports from US intelligence and international agencies such as the IAEA suggest a delay of several months/years but not total destruction. Tougher security measures, including **crackdowns and arrests**, underway by the Iranian security forces - **Bushehr Province**: at least 3 people killed in a fire at a petrochemical plant in Bandar Deyr (11 June).

#### **Israel/Palestine**

13 to 24 June, daily Iranian missile and drone attacks in retaliation to Israel's Operation Rising Lion targeting Iran. In total, around 600 missiles were fired from Iran at Israeli territory (88% interception rate by air defence), namely the regions of Tel Aviv, Haifa and Be'er Sheva, in which 29 people were killed and tens of buildings were damaged. The conflict resulted in the suspension of domestic air traffic for 13 days and occasionally regional traffic - Bill for the dissolution of parliament rejected amid tension that broke out among the majority over the issue of conscription for ultra-Orthodox Jewish men - Gaza: Israel continued its military operations despite the conflict with Iran. At least 250 people subsequently killed in bombing raids (1, 2, 4, 12, 19, 26 June), notably close to food distribution centres - West Bank: violent attacks by Israeli settlers on the village of Kafr Malik (near Ramallah), 3 Palestinians killed. A vast Hamas network dismantled near Hebron by Shin Bet (29 June); more than 60 people arrested, 22 firearms and grenades seized, discovery of an underground hideout. Major military operation in Nablus, at least one dead (11 June).

#### Kenya

Major cities: violent clashes during anti-government demonstrations (24-25 June), notably in Nairobi, Kisumu, Mombasa, on the fringes of the commemoration of the fierce crackdown on the 2024 citizen uprising (more than 60 dead). Reports indicated stone-throwing, fires, tear gas, stun grenades and live-round fire. At least 19 dead, 15 missing, 531 injured and 179 arrested. The Kenyan government claimed to have foiled an attempted coup. Several Western chancelleries warned that the authorities had resorted to the use of masked police officers to disrupt the demonstrations - Nairobi: clashes broke out during demonstrations against police violence (2, 12, 16 June), staged following the controversial death of activist, Albert Ojwang, whilst in custody 8 June (at least one dead 16 June). Clashes reported between the police and street vendors in the CBD (13 June). Nakuru County: tanker explodes on the Nakuru-Nairobi road, causing a fire to break out involving other vehicles. At least 2 people injured (14 June).

#### Nigeria

Niger State: at least 200 dead and 500 missing following flooding (3 June). 20 soldiers killed in a large-scale assault carried out by suspected bandits on a military base near Bangi (24 June). Roadblocks set up by students towards Lapai (23 June) - Benue: 25 dead in attacks by suspected armed herdsmen in the areas of Ankpali and Naka (1 June), several dead and a major roadblock on the Makurdi-Naka thoroughfare (6 June). Clashes reported during a demonstration in Makurdi (15 June), in the wake of an attack attributed to armed herdsmen, in which around one hundred people were killed in Yelewata (14 June) - Zamfara: 20 dead in an attack by armed bandits on the village of Mani and a military air strike carried out by mistake between the villages of Maraya and Wabi (31 May). Around one hundred suspected members of a criminal gang killed in clashes with the local defence forces in Shinkafi District (26 June) - Plateau: 19 people killed in inter-communal clashes in the areas of Mangu and Bassa (9-10 June).

15 dead in attacks by armed men in the areas of Bokkos and Mangu (20 June) - **Borno**: 20 members of a local anti-Jihadist group killed in a suspected Boko Haram suicide attack in Konduga (20 June) - **Rivers**: 21 athletes killed in a bus accident in the Kula region (1 June) - **Nationwide**: demonstrations on the occasion of Democracy Day 12 June - **Abuja**: security stepped up around the secretariat of the Peoples Democratic Party (PDP) for a sensitive meeting (30 June).

#### United Kingdom

County Antrim and County Armagh (Northern Ireland): several nights of rioting and violence during anti-immigration demonstrations in Ballymena, Newtownabbey, Portadown, Londonderry after 2 people were charged with attempted rape. At least 32 police officers injured, businesses damaged, a leisure centre and houses set on fire (10-18 June) - Greater Manchester: one dead in a knife attack in Nevin Road, resulting in 3 arrests (8 June). Security stepped up in Salford following unrest caused by 60 masked youths (11 June). Fire in an uninhabited building resulting in the suspension of rail services at Oxford Road Station (23 June) - Liverpool: 2 June announcement of 109 people injured, 4 seriously, and one suspect arrested following the incident involving a vehicle that had driven into a crowd of people gathered to celebrate the victory of Liverpool FC 26 May - Belfast: security stepped up and a suspect arrested following an attack on a place of worship (20 June) - Wales: traffic suspended due to a vehicle fire in Conwy Tunnel (19 June) - Buckinghamshire: disruption caused by a derailed train around Milton Keynes (26 June) -London: one person injured, traffic suspended following a vehicle collision on London Bridge (11 June). 6 people injured in a traffic accident at Piccadilly Circus (29 June). Numerous demonstrations, especially pro-Palestinian (4, 21, 28, 30 June), against austerity policy (7 June), concerning the assisted dying bill (13, 20 June). Clashes between activists from the Palestine Action group and the police on Trafalgar Square (23 June). Glasgow: metro strike (25-28 June).

#### Thailand

Persistent tension with Cambodia in the wake of an armed skirmish in the border area 28 May (one Cambodian soldier killed). Ban Laem and Ban Phakkat border crossings closed 7 June, then all borders in the provinces of Surin, Buriram, Sri Sa Ket, Sa Kaeo, Chanthaburi and Trat 23 June. Further travel restrictions implemented: Bangkok-Phnom Penh buses suspended, cross-border trips limited to 7 days for the nationals of both countries, movement of goods limited. The Constitutional Court suspended Thai Prime Minister Paetongtarn Shinawatra 1 July, suspected of breaching ethical standards in relation to a controversial telephone call with former Cambodian Prime Minister Hun Sen, broadcast without her consent - Pattani Province: 7 people injured when 3 bombs exploded outside the fairground at Somdet Park in Pattani (20 June) - Phuket Province: security stepped up and suspect arrested after suspected attempted bombings were foiled, notably at Phuket Airport (25 June) - Provinces on the Andaman Coast: tsunami preparation drill (27 June) -Bangkok: demonstrations against the government (from 19 June), Gay Pride (1, 27 June, also in Pattava), and for sovereignty (5-6 June).

#### Türkiye

Muğla Province: at least 1 dead and 70 people injured when an earthquake measuring 5.8 struck near lcmeler, major structural damage (3 June) - Izmir Province: huge forest fires in several districts, destroying some twenty houses (29, 30 June) - Istanbul: clashes and 87 people arrested during the commemoration of the Gezi Park protest movement (31 May), as well as more than 50 people arrested ahead of the Gay Pride event banned by the authorities (29 June). Various demonstrations, notably in condemnation of the arrest of presidential candidate, Istanbul Mayor Ekrem İmamoğlu (1, 4, 18, 25 June), led by municipal workers (3 June), trade unions (15, 18 June), pensioners (20 June) and lawyers (23 June) - 5 mayors from the CHP opposition party placed in pretrial detention within the framework of a major investigation into corruption, while the CHP, the clear winner of the 2024 local elections, is under growing legal pressure.

# Events to look out for in July

#### 26 June onwards

**Muslim World**: holy month of Muharram – Security reinforcements and disruption should be expected.

#### 27 June to 5 July

India: Hindu celebration of Jagannath Rath Yatra in Odisha State - Large numbers of people likely to attend, security reinforcements and travel disruption should be expected.

#### 1 July

**Bangladesh**: first anniversary of the start of the student demonstrations that resulted in the government being overthrown – Security reinforcements should be expected.

**Benin**: activist from the main opposition party critical of the government set to stand on trial – Security to be stepped up.

**Canada**: independence celebrations on the occasion of Canada Day (1867) - Security reinforcements in major cities should be expected.

**China**: 104th anniversary of the founding of the Communist Party of China (CPC) – Celebrations likely, notably in Beijing.

**Democratic Republic of the Congo**: political demonstration in support of the president in Kinshasa – Security reinforcements should be expected.

**Ghana**: Republic Day (1960) - Security reinforcements and commemorations should be expected.

**Hong Kong (SAR)** : 28th anniversary of the handover of Hong Kong to China (1997) – Security reinforcements likely, official events, though limited, are likely to be held on public squares (Golden Bauhinia Square) and in government buildings.

**Indonesia**: 54th anniversary of the Free Papua Movement (OPM) (1971) – Security reinforcements to be expected and incidents should not be ruled out in Papua Province.

**Mali**: 12th anniversary of the first deployment of the United Nations Multidimensional Integrated Stabilisation Mission in Mali (MINUSMA, 2013).

Poland: 34th anniversary of the Warsaw Pact.

**Somalia**: 65th anniversary of independence (1960) – Security reinforcements should be expected, notably in Mogadishu.

**Tanzania**: hearing in the trial of the leader of the opposition, Tundu Lissu, accused of treason – Security reinforcements should be expected.

**United States**: national day of action against ICE – Localised disruption should be expected.

#### 2, 4, 7 July

**Finland**: series of national trade union strikes at Helsinki Airport – Flight disruption and longer waiting times should be expected.

#### 2 July

**France**: risk of demonstrations staged by the FFB construction union in protest against the end of housing renovation grants – Disruption should be expected. **Kosovo**: farmers set to demonstrate in Pristina – Security reinforcements and traffic disruption should be expected.

**Portugal**: demonstration in the vicinity of Lisbon Humberto Delgado Airport – Security reinforcements and traffic disruption should be expected.

**United Kingdom**: demonstration in support of Palestine Action in London – Security reinforcements and disruption should be expected.

**Türkiye**: 32nd anniversary of the Sivas massacre (1993) - Commemorative rallies should be expected in major cities, namely Sivas, Ankara and Istanbul.

#### 3 July and 4 July

**South Korea**: demonstration in support of former President Yoon Suk Yeol in Seoul – Security reinforcements and disruption should be expected.

**France**: strike notice issued by air traffic controllers – Flight disruption should be expected.

#### 3 July to 8 August

**India**: annual Amarnath Yatra Hindu pilgrimage – Security reinforcements and disruption should be expected.

#### 3 July

**Belarus**: Independence Day – Security reinforcements and commemorations should be expected.

**Egypt**: 12th anniversary of the coup that led to President Mohamed Morsi being overthrown (2013).

**Portugal**: trade union-led demonstration in Lisbon – Security reinforcements should be expected, risk of roads to the airport being blocked.

#### 4 to 5 July

**Ivory Coast**: annual rally organised by politician and former First Lady Simone Ehivet Gbagbo in Abidjan – Security could be stepped up.

#### 4 July

**Australia**: demonstration in front of the US Consulate in Melbourne – Security could be stepped up.

**Colombia**: 61st anniversary of the creation of the National Liberation Army (ELN) (1964) – ELN attacks guerrilla possible.

**Germany**: demonstration outside the US Embassy in Berlin – Disruption should be expected.

**Ivory Coast**: political demonstration in Abidjan – Security could be stepped up, tension should not be ruled out.

**Malawi**: national opposition demonstrations – Disruption should be expected, including a risk of unrest.

**Mexico**: demonstration in Mexico City against the FIFA 2026 World Cup – Security reinforcements possible.

**Poland**: 79th anniversary of the Kielce pogrom (Świętokrzyskie Voivodeship, 1946) – Security reinforcements likely on the fringes of the commemorations.

**Rwanda**: Liberation Day, marking the end of the genocide in 1994 – Commemorations likely.

**Sri Lanka**: 48-hour national rail strike – Train disruption should be expected. **United States**: Independence Day (1776) – Celebrations and increased security should be expected nationwide.

**United States**: anti-Trump demonstration in Washington DC – Security could be stepped up, a counter-demonstration should not be ruled out.

#### 5 to 6 July

**Muslim World**: celebrations of Ashura, including the main pilgrimage to Karbala (Iraq) - Disruption likely.

#### 5 to 25 July

**France**: annual Festival d'Avignon – Increased security and travel disruption should be expected.

#### 5 to 27 July

**France**: Tour de France cycle race – Increased security and disruption should be expected along the whole route.

#### 5 July

**Algeria**: 63rd anniversary of the declaration of independence (1962) – Commemorative events and disruption should be expected.

**Cape Verde**: 50th anniversary of independence – Celebratory events and disruption should be expected.

**China**: 16th anniversary of the start of deadly rioting in the Xinjiang Uyghur Autonomous Region (2009) – Security reinforcements likely in Xinjiang. **Croatia**: large public concert scheduled in Zagreb – Major traffic disruption should be expected, importantes de la circulation à attendre, avoid travelling to or around the city.

**Germany**: demonstration led by the far-right and a counter-demonstration to be staged by civil society in Munster – Security reinforcements should be expected, risk of incidents between rival demonstrators.

Rwanda: 52nd anniversary of the 1973 Rwandan military coup against

President Grégoire Kayibanda, who had led the country since independence in 1962 – Commemorations likely.

**United Kingdom**: Pride in London – Security reinforcements and disruption should be expected.

**Venezuela**: Independence Day (1811) - Security reinforcements and commemorations should be expected.

#### 6 to 7 July

**Brazil**: BRICS summit of heads of state and government – Security reinforcements and disruption should be expected.

#### 6 to 8 July

**Spain**: Africa Spain Cooperation Summit – Security reinforcements and disruption should be expected.

#### 6 to 14 July

**Spain**: Festival of San Fermín in Pamplona, including the traditional release of the bulls – Massive crowds and disruption should be expected.

#### 6 July

**China**: Dalai Lama's 90th birthday – Demonstrations possible in Tibetan-majority provinces.

**Malawi**: Independence Day (1964) – Security reinforcements and commemorations should be expected.

#### 7 to 8 July

Italy: national rail strike - Train disruption should be expected.

#### 7 July

Algeria: indefinite national rail strike – Train disruption should be expected.
China-Taiwan: 88th anniversary of the Marco Polo Bridge Incident (1937), marking the start of the Second Sino-Japanese War – Commemorations likely.
Greece: 6th anniversary of the election of Prime Minister Kyriakos Mitsotakis (2019) – Opposition demonstrations possible, notably in Athens.

**Kenya**: Saba Saba Day commemorating the death of demonstrators in 1990 – Commemorations likely.

**Myanmar**: 63rd anniversary of the crackdown on student demonstrations 1962 – Commemorations likely.

**United Kingdom**: 20th anniversary of the London Bombings, suicide attacks carried out by terrorists on public transport, which left 52 people dead and 700 injured – Remembrance ceremonies should be expected.

**United States**: Israeli Prime Minister Benjamin Netanyahu to pay a visit to the White House – Security reinforcements should be expected, demonstrations possible. **Yemen**: 31st anniversary of the end of the civil war between the north and south (1994).

#### 8 to 10 July

**United Kingdom**: State Visit by French President Emmanuel Macron and his wife – Security reinforcements and disruption should be expected.

#### 8 to 11 July

**Malaysia**: 58th Foreign Ministers' Meeting of the Association of Southeast Asian Nations (ASEAN) at the Kuala Lumpur Convention Centre – Security reinforcements and disruption should be expected.

#### 8 July

Israel/Palestine: 11th anniversary of Israel's Operation Protective Edge in Gaza (2014) – Risk of demonstrations, or even violence given the ongoing war.
New Zealand: 40th anniversary of the bombing of the Rainbow Warrior in Auckland – Remembrance ceremonies possible.

#### 9 to 18 July

**Taiwan**: Han Kuang annual live fire military drills – Heightened tension in the region should be expected.

#### 9 July

**Argentina**: Independence Day (1816) - Security reinforcements and commemorations should be expected.

**Iran**: 26th anniversary of the student protests (1999) – Anti-government demonstrations possible.

**South Sudan**: 14th anniversary of independence (2011) – Commemorations likely. **United States**: end of the US pause on higher tariffs to be imposed on the EU and other countries.

#### 10 to 11 July

**Italy**: 4th Ukraine Recovery Conference 2025 in Rome – Security reinforcements and disruption should be expected.

#### 10 July

Italy: 49th anniversary of the Seveso environmental disaster (1976).
Mauritania: 27th anniversary of the 1978 coup – Armed Forces Day, Security reinforcements and commemorations likely.
North Macedonia: air traffic controller unions call for strike action – Flight disruption should be expected.

#### 11 July to 13 July

**United Kingdom**: Glasgow metro strike led by the Unite Union – Traffic disruption should be expected.

#### 11 July to 9 August

**India**: security stepped up for the Kanwar Yatra Hindu pilgrimage, notably in Uttarakhand State – Disruption should be expected.

**Bosnia-Herzegovina**: 30th anniversary of the Srebrenica massacre (1995) – Commemorations likely.

**India**: 19th anniversary of the bomb attacks on trains and stations in Mumbai (189 dead, 2006) – Commemorations likely.

**Democratic Republic of the Congo**: 65th anniversary of the secession of Katanga (1960) – Security reinforcements likely.

#### 12 July

**United Kingdom** (Northern Ireland): commemoration of the Battle of the Boyne (1690), marking a victory for the Protestants over the Catholics – Tension possible on the occasion of the public holiday in Northern Ireland.

#### 13 July

**Pakistan**: Kashmir Martyrs' Day, commemorating the death of 21 Kashmiri demonstrators in 1931– Demonstrations likely.

#### 14 July

**Belgium**: EU tariffs on US products set to come into force in retaliation for US taxes on steel and aluminium.

**France**: anniversary of the terrorist attack by the Islamic State (IS) group on the Promenade des Anglais in Nice (86 dead, 2016) and Bastille Day celebrations across the country – Security reinforcements and disruption should be expected. **Hong Kong** (SAR): 114 imprisoned Hong Kong democrats to appeal their conviction for subversion under the National Security Law – Security reinforcements should be expected, demonstrations should not be ruled out.

#### 15 July to 17 July

**Singapore**: Asia Pacific Summit for Aviation Safety – Security reinforcements and localised disruption should be expected.

#### 15 July

Brunei: Sultan Hassanal Bolkiah's 79th birthday (born 1946) – National celebrations.
Cyprus: 51st anniversary of the coup fomented by the Greek junta which led to the Turkish invasion in the north of the island (1974) – Commemorations should be expected.
Russia: anniversary of the assassination of human rights activist, Natalia Estemirova in Grozny (Chechnya) 15 July 2009 – Commemorations possible.
Türkiye: anniversary of the attempted coup against President Recep Tayyip Erdogan (2016) – Commemorations likely.

#### 16, 18, 21 and 23 July

**Finland**: trade union-led strike action at Helsinki Airport – Flight disruption should be expected.

#### 16 July

**Ivory Coast**: appeal trial of a unionised teacher sentenced to two years' imprisonment – Demonstrations should not be ruled out.

**Finland**: strike action at Helsinki Airport announced by an aviation trade union - Flight disruption should be expected

**France**: anniversary of the mass roundup of Jews at the Vélodrome d'Hiver in Paris (1942) – Remembrance ceremonies likely.

**Türkiye**: possible resumption of the trial of Istanbul mayor Ekrem İmamoğlu – Security reinforcements should be expected, demonstrations should not be ruled out.

#### 17 to 23 July

**Kenya**: legal investigation into the murder of Rex Masai during the anti-government demonstrations of 2024 – Security reinforcements should be expected, demonstrations should not be ruled out.

#### 17 July

**France**: French courts set to rule on the release of Georges Abdallah – Security reinforcements to be expected, demonstrations should not be ruled out.

**Togo**: municipal elections (initially scheduled 10 July) – Security reinforcements and disruption should be expected.

**Ukraine**: 11th anniversary of the crash of flight MH17, shot down by a missile (298 people on board, 2014).

#### 18 July

Argentina: 31st anniversary of the bomb attack on the AMIA jewish centre in Buenos Aires (85 dead, 1994) - Commemorations likely.
South Africa: Nelson Mandela's birthday (1918) – Commemorations likely.
Spain: anniversary of the start of the Spanish Civil War (1936) – Remembrance ceremonies possible.

#### 19 July

Monaco: celebrations to mark 20 years of Prince Albert II's reign –
Commemorations and increased security should be expected.
Myanmar: Martyrs' Day – Anti-junta demonstrations possible.
Nicaragua: anniversary of the capture of Managua by the Sandinista National Liberation Front (FSLN) in 1979.

#### 20 July

**Cyprus**: 51st anniversary of the start of the Turkish invasion of the north (1974) – Demonstrations should not be ruled out, notably in Nicosia. **Colombia**: Independence Day (1810) – Celebrations likely across the country.

#### 22 July

**China**: anniversary of the ban on the Falun Gong cult (1999). **Norway**: anniversary of the terrorist attacks in Oslo and Utøya (77 dead, 151 injured) claimed by a right-wing extremist (2011) – Remembrance ceremonies likely.

#### 23 July

**Burundi**: senatorial elections – Security reinforcements and disruption should be expected. **Egypt**: 20th anniversary of a series of bombings in the Egyptian resort of Sharm el-Sheikh – Commemorations should be expected.

**Morocco**: anniversary of the death of King Hassan II of Morocco and Mohammed VI's accession to the throne (1999) – Commemorations expected, notably in Marrakesh and Rabat.

**Papua New Guinea**: National Remembrance Day – Ceremonies likely, especially in Port Moresby.

#### 26 July

**Cuba**: National Rebellion Day (1953) – Ceremonies likely, notably in Havana and Santiago de Cuba.

**France**: anniversary of the killing of a priest in Saint-Etienne-du-Rouvray by a sympathiser of the Islamic State (IS) – Remembrance ceremonies likely.

**Liberia**: Independence Day (1847) – Celebrations and security reinforcements to be expected.

**Taiwan**: 24 opposition MPs subject to recall votes – Demonstrations should not be ruled out.

**North Korea**: 72nd anniversary of the end of the Korean War (1953). **Venezuela**: municipal elections – Rallies should not be ruled out.

#### 28 July to 3 August

**India**: Naxalite Martyrs' Week – Surge in attacks should not be ruled out, strike action possible in Naxalite areas.

#### 28 July

**Peru**: Independence Day – Celebrations should be expected.

**Thailand**: birthday of King Maha Vajiralongkorn (Rama X) – Celebrations likely, especially in Buddhist temples and in the capital and demonstrations should not be ruled out.

**United Kingdom**: 20th anniversary of the IRA laying down their weapons following 35 years of conflict – Commemorations should be expected. **Venezuela**: first anniversary of the re-election of President Nicolas Maduro – Rallies and tension should not be ruled out.

#### 30 July

**El Salvador:** commemoration of the 1975 student "massacre" in San Salvador – Demonstrations possible.

**Morocco**: Throne Day – Official and popular ceremonies to be expected. **South Sudan**: Martyrs' Day - Commemorations should be expected.

#### 31 July

**Spain**: anniversary of the creation of the Euskadi Ta Askatasuna (ETA, 1959), officially dissolved in May 2018.
